#### Counsel to the Fund/GP

commitments from large European family offices and multilateral institutions.

#### Co-investment Structures

- Bain and Piramal Platform (India and U.S) in setting up the distressed asset platform launched by Piramal and Bain named 'India Resurgence Fund' and assisted in successful closure of the platform by accepting investments from leading financial institutions and global development financial institutions. In the role of the fund counsel, worked closely with the investment funds team of a U.S. based law firm in Boston and ensured successful fund-raising. One of the unique features of the platform was collapsing the Cayman structure into a Mauritius pooling platform for tax and structuring purposes and successfully migrating investors from Cayman into Mauritius; and
- Ambit Portman Joint Venture (India and U.S) in the setting up of the Ambit Portman joint venture which leveraged the expertise of Portman Holdings in real estate investing and Ambit Holdings' local fund-raising abilities and assisted the joint venture in the successful closing of its first fund.
